

SUBMISSIONS: We invite you to submit a health-related manuscript to the *Yale Journal of Health Policy, Law, and Ethics*. Please include (1) your current address, telephone number, E-mail address, and CV; (2) three printed copies of the manuscript (triple-spaced); and (3) a 100-word abstract. Articles should be no more than 14,000 words and should be sent to the address listed below. Details about our editorial style are available on our website. The submission deadline for the Spring 2003 issue is July 1, 2002, and the submission deadline for the Fall 2003 issue is January 1, 2003.

PEER REVIEW: All articles submitted to the *Journal* are peer reviewed. For a detailed description of the process, please visit our website.

SUBSCRIPTIONS: The *Journal* is published biannually. Subscriptions are \$29 per year for individuals and \$39 for institutions. Institutional rates apply to libraries, law firms, institutions, and individuals whose employer pays for subscriptions. Please add \$10 for overseas mailing. For your convenience, a subscription card is located in the back of this issue.
